December 10, 2015

The meeting was called to order at 7:30 p.m. by Susan.

She welcomed everyone and new members were introduced.

The **minutes** from the October meeting were accepted as read by Seth.

The treasurer's report was accepted as read by Joe (Doug couldn't be present).

The **field safety report** was given by Glen, who said we are getting busier at the field now that many members are returning, and he reminded everyone to be inside the pilots' box before calling out that you are taxiing onto the runway, and to make all your calls loud enough to be heard and acknowledged.

Jay gave his Chief Training Officer's report, and has posted a new list of instructors on the pressbox window and on the website. The importance of wearing your club card at the field was repeated.

Newsletter/web page: Joe said that thanks to the free classified ads, guys are selling things, and he always needs and welcomes pictures, articles, and classified ads.

Events: Sue reported on the successful Toys For Tots event, which raised \$1380. The South Florida Fair next month always needs volunteers to help assemble Delta Darts. Contact Pete Ferris if interested. And the club's annual **Swap Meet** will be on Sunday, February 14th. Contact Nooch for table reservations. **The IMAC event** will be on May 21st and 22nd.

Ground Maintenance: We received an estimate of \$3700 for resealing the runway, and expect to receive another estimate. A vote to accept the \$3700 bid if necessary was passed. Anyone opening the containers must re-lock them properly, closing the locks inside the protective covers. Also, the club's Port-a-Potty next to the hover area must be kept locked. And construction on the Eagle Scouts project to build 3 new startup stands will be starting soon.

New Business: After a short coffee & donuts break (with thanks to Susan & Joe for the refreshments), the purchase of a \$139 solar panel to supplement the existing panels was proposed by Hugo and was authorized by Sue. Three Director positions are open for nominations. Doug (treasurer), Joe (newsletter) and Jay (training) were the only nominations so far. Nominations close at the Jan. mtg. with the election in Feb. The roof repair on the large container will be done by Brooklyn Joe Mannino and Steve Prew and will be a bigger repair than originally expected. Steve spoke about possibly taking off from the runway in a northern direction if any other pilots who may be flying don't object. The rules require that all takeoffs, landings, and flying must be north of the south edge of the paved runway and not wherever the cones may be on the grass.

Bill Siegel presented a Show & Tell airplane. Theres was no 50-50 drawing.

Our next meeting will be on January 14th, 2016.

The Palm Beach Radio Control Association BOOK OF THE MONTH A Shelly Portnoy book review !

The Wright Brothers, a book written by two-time Pulitzer Prize winner, David McCullough.

By the very nature of this story, I felt a short review could be considered appropriate for our renowned news periodical. This book, a recent best seller release, is available at our public libraries. The writing skills of Mr. McCullough takes the reader up front and personal into the Wright Bros. and their family throughout their tedious trials concluding with tribulations for the brothers who successfully conquered gravity by creating a heavier than air powered flying machine able to carry man above earth.

When the brothers worked together, no problem seemed insurmountable. Not even the possibility of being killed. They built and conducted wind tunnel tests to evaluate different airfoils and wing shapes, which none of the other 100 or more learned aviation experimenters addressed.

One might ask, "why wing warping instead of ailerons"? In fact, one of over 200 patents that they were awarded, indicated ailerons drawn with dotted lines and referred to as small wings to control (roll) lateral stability. They felt, to be successful, a close as possible emulation of how birds control their flight would lead to achievement, and that proved to be true. They even produced an algebraic formula indicating placement for the center of lift which was important in determining location for the center of gravity. Formulas from other experimenters proved to be false.

A prominent American scientist and head of the Smithsonian Institution, Samuel Langley, designed and constructed a machine, that he guaranteed would fly. He also accepted \$80k from our government for his project. They located the machine on top of a house boat floating in the Potomac River. When Langley as the pilot pulled the release mechanism, the contraption was catapulted 50 feet into the air, stalled and then without hesitation, dropped into the river and sank. Luckily, he was rescued and upon regaining his composure, he declared that man will never produce a machine that would fly as gravity is too strong. He, as well as many other Americans considered all the news regarding the Wright Brothers success as fraudulent.

I believe skepticism is part of our culture. When Thomas Edison wanted to light up NYC, we said no, as we thought it was dangerous and wouldn't work. We also didn't want to put thousands of candle and lantern workers out of jobs. Then, they even tried to stop the automobile from expanding as NYC would be the recipient of 3,000 unemployed horses. And who is going to feed them? Sharing our wealth to feed horses that can't work would create socialism.

For me, their story is so honest and uplifting that I recommended it to my wife, Ruby who agreed to read it if I can assure her that there is no mention of football anywhere in this read. I told her that if there is even one word of football, I will scream and jump out the window. Lol. Which by the way is about three feet above soft grassy ground. Ruby enjoyed the read and recommended it to many of her friends.

The AMA has recommended that our members hold off on registering their model aircraft with the FAA until advised by the AMA or until the FAA's legal deadline of February 19. Holding off on registration will allow time for AMA to fully consider all possible legal and political options for alleviating this unnecessary regulatory burden on our members.

In the meantime, you can help by making your voice heard with the FAA. Specifically we are asking all AMA members to submit comments on the FAA's interim rule on registration. The deadline to submit comments is January 15, 2016. All comments can be submitted at http://l.usa.gov/1Jegj0C.

Below are recommended messages to convey in your comments:

- Express your disappointment with the registration rule. As a member of the Academy of Model Aeronautics (AMA), I am disappointed with the new rule for UAS registration. I am a long time model aircraft flyer, who has operated under the guidance of the largest community-based organization (CBO) in the world for many years.
- Highlight AMA's history and safety record. Since 1936, AMA has published safety standards and offered training programs for our members - more than 20 years before the FAA was created. Our National Model Aircraft Safety Code has been recognized by Congress as well as by state legislatures as a safe and effective means of managing model aircraft enthusiasts like me
- Note that you already register with AMA. Additionally, AMA's safety program already instructs me to place my AMA number or name and address on or within my model aircraft(s), effectively accomplishing the safety and accountability objectives of the interim rule.
- Make it clear this rule is contrary to the intent of Congress. The new rule is contrary to the intent of Congress in Section 336 of the 2012 FAA Modernization and Reform Act. Section 336, also referred to as the "Special Rule for Model Aircraft," clearly prohibits the FAA from promulgating any new rules for recreational users operating within the safety guidelines of a CBO. In addition, the FAA's contention that model aircraft should be considered aircraft is currently the subject of pending litigation.
- Affirm that as an AMA member you should be exempt from federal registration. The registration process is an unnecessary burden for me and the more than 185,000 other AMA members. AMA members should not be required to register with the FAA.

Academy of Model Aeronautics Member Communication

Dear AMA Members,

Yesterday, the AMA Executive Council unanimously approved an action plan to relieve and further protect our members from unnecessary and burdensome regulations. This plan addresses the recently announced interim rule requiring federal registration of all model aircraft and unmanned aircraft systems (UAS) weighing between 0.55 and 55 pounds.

AMA has long used a similar registration system with our members, which we pointed out during the task force deliberations and in private conversations with the FAA. As you are aware, AMA's safety program instructs all members to place his or her AMA number or name and address on or within their model aircraft, effectively accomplishing the safety and accountability objectives of the interim rule. AMA has also argued that the new registration rule runs counter to Congress' intent in Section 336 of the FAA Modernization and Reform Act of 2012, otherwise known as the "Special Rule for Model Aircraft."

The Council is considering all legal and political remedies to address this issue. We believe that resolution to the unnecessary federal registration rule for our members rests with AMA's petition before the U.S. Court of Appeals for the District of Columbia. This petition, filed in August 2014, asks the court to review the FAA's interpretation of the "Special Rule for Model Aircraft." The central issue is whether the FAA has the authority to expand the definition of aircraft to include model aircraft; thus, allowing the agency to establish new standards and operating criteria to which model aircraft operators have never been subject to in the past.

In promulgating its interim rule for registration earlier this week, the FAA repeatedly stated that model aircraft are aircraft, despite the fact that litigation is pending on this very question. The Council believes the FAA's reliance on its interpretation of Section 336 for legal authority to compel our members to register warrants the Court's immediate attention to AMA's petition.

While we continue to believe that registration makes sense at some threshold and for flyers operating outside of a community-based organization or flying for commercial purposes, we also strongly believe our members are not the problem and should not have to bear the burden of additional regulations. Safety has been the cornerstone of our organization for 80 years and AMA's members strive to be a part of the solution.

As we proceed with this process, we suggest AMA members hold off on registering their model aircraft with the FAA until advised by the AMA or until February 19, the FAA's legal deadline for registering existing model aircraft.

Holding off on registration will allow AMA time to fully consider all possible options. On a parallel track, it also allows AMA to complete ongoing conversations with the FAA about how best to streamline the registration process for our members.

In the near future, we will also be asking our members to make their voices heard by submitting comments to the FAA's interim rule on registration. We will follow-up soon with more detailed information on how to do this.

Thank you for your continued support of AMA. We will provide you with more updates as they become available.

AMA and the FAA Registration Process

Today the FAA announced plans for a model aircraft registration process to begin next week. AMA was a member of the task force that helped develop recommendations for this registration rule and argued throughout the process that registration makes sense at some level but only for those operating outside the guidance of a community-based organization or flying for commercial purposes.

Unfortunately, the new FAA registration rule does not include our advice. The rule is counter to Congress's intent in the Special Rule for Model Aircraft and makes the registration process an unnecessary burden for all of our members who have been operating safely for decades.

While we are disappointed with the new registration rule and still maintain that AMA members should be exempt from registration, the rule is being implemented over AMA objections. Therefore, we want to provide you with important information about the registration rule and how AMA members can comply with the new federal requirements:

- All aircraft that are flown using a ground control system, such as a transmitter, are required to participate. This
 includes fixed-wing aircraft, not just multirotors or drones.
- Any pilot flying models weighing between .55 pounds (or 250 grams) and 55 lbs is required to register.
- You will not be required to register every aircraft individually. You only need to register yourself and can affix one registration number to all your aircraft.
- You must mark all aircraft with your registration number. The number can be inside the aircraft, such as a battery hatch - but should not require tools to access.
- The FAA plans to launch the online registration website on Monday, December 21.
- There is a \$5 fee to register, which is waived if you register within the first 30 days.
- You only need to register once every 3 years.

We are still working out the logistics for this process. Some details are still being discussed, including:

- We are seriously discussing with the FAA a system where your AMA number could be used as your federal
 registration number as well. At this point, this is only a proposal and details are not yet finalized.
- At this time, AMA members will not automatically be registered when the registration website launches next week. However, we are in conversations with the FAA about the best way to streamline the registration process for AMA members going forward.

This is an ongoing process and we will continue to provide updates on the registration rule. Stay tuned to modelaircraft.org/gov, social media and your email for the latest news on the registration process.
